## 1. What is this survey and what does it aim to achieve?

Integrating technology into educational centres is now a reality around the world, especially since the onset of the COVID-19 pandemic. This event has fast-tracked the transformation of the face-to-face teaching and learning process to a remote and hybrid model to which all teachers and students have had to adapt. It is time to find out how teachers across all educational stages in European and Latin American countries are currently dealing with the use of technology in their classrooms.

In order to understand this reality, the Innovation and Educational Improvement Research Group (IMEI) of the Rey Juan Carlos University, together with BlinkLearning<sup>1</sup>, is carrying out a survey for the seventh consecutive year to analyse the opinions of teachers in European and Latin American countries who currently use technology in their classrooms.

**GENERAL OBJECTIVE:** find out the current use and integration of technologies in the classroom of the participating teachers after the onset of pandemic.

**SPECIFIC OBJECTIVES:** Analyse (1) the current digitalisation process in educational centres and its impact on teaching and learning, (2) the overall view on Education and (3) the opinion on the teaching profession nowadays, all this from the teachers' perspective.

#### 2. How will the survey be conducted?

The procedure for distributing the questionnaire will involve two parts:

1.- The **IMEI Research Group** will distribute the survey through the research teachers social media and through the institutional email of the Rey Juan Carlos University teachers. This will be done with the help of the Faculty of Legal and Social Sciences (of which the research group is part) and/or through the coordinators of the Bachelor's Degrees in Education and the Master's Degree in Teacher Training. The email will include the main information about the survey (objectives, etc.), a link to the *Information Sheet* and a direct link to the form inviting participants to voluntarily and anonymously take the survey.

2.- **BlinkLearning** will also distribute the form on its website (www.blinklearning.com) and on its social networks (@Blinklearning, etc.).

The questionnaire has been developed through the *SurveyMonkey* platform after being validated by 10 experts in Education, in general, and technology applied to Education, in particular, from both Spain and Latin America.

The survey methodology will be quantitative, with a qualitative analysis of the final open-ended question, in order to understand and categorise the comments/reflections made by the participants.
